

ROYAL SCOT 2025 GOLF LEAGUE CONTRACT

IMPORTANT --- THE OFFICERS AFFIRM IN SIGNING THIS CONTRACT THAT THEY HAVE BEEN AUTHORIZED BY THE LEAGUE TO ENTER INTO THIS AGREEMENT SETTING FORTH THE TERMS, CONDITIONS AND OBLIGATIONS WHICH ARE ASSUMED BY THE PARTIES.

THIS AGREEMENT, made this March day of 10 2025 between the Farm Bureau Golf League, composed of 160 golfers, hereinafter referred to as the League and Royal Scot golf course, hereinafter referred to as the COURSE.

The COURSE shall reserve the LEAGUE NINE HOLES (alternating all three nines) for a period of up to 21 weeks every Thursday, (with exceptions of legal holidays) with tee-off times from 4:00 p.m. to 4:21 p.m. (Extension of time as conditions warrant may be made at the sole discretion of the COURSE). The 2025 season will start on April 24, 2025 and will end Sept 18, 2025. NO INDIVIDUAL, TEAM, OR LEAGUE MAKEUPS WILL BE ALLOWED.

IN CONSIDERATION of the above, the LEAGUE agrees to pay the COURSE at the rate of 320⁰⁰ per golfer making the total league payment \$ 5120⁰⁰ for the 2025 season. Due to the ever-increasing cost of goods, labor, taxes and services, the price of golfing in the contracts may be adjusted per cost of living index on or before the first scheduled league session. The adjustment cannot exceed 10%. LEAGUE AGREES TO PAY 100% OF THE PAYMENT THE FIRST NIGHT OF LEAGUE PLAY. If payment is not paid in full the first night the league will not be allowed to start.

This contract shall be construed solely as a privilege to the COURSE facilities in an orderly manner and the COURSE reserves the right at any time, in their sole discretion, to refuse the use of said COURSE to any person or persons who conduct themselves in a manner unbecoming ladies or gentlemen, or WHO DISREGARD THE COURSE RULES.

RESPONSIBILITIES OF THE COURSE:

1. The COURSE will furnish score cards to LEAGUE members.
2. The COURSE will provide the LEAGUE with the best possible conditions.
3. The COURSE and/or its representatives shall not be responsible for any damage or theft of equipment, clothing, motor vehicle, nor any items contained therein, unless specifically agreed to by the COURSE.
4. The COURSE reserves the right to cancel LEAGUE play when, it determines it is necessary for the protection of the LEAGUE and /or the course.
5. The COURSE reserves the right to postpone one scheduled day of LEAGUE play for a special tournament event upon notice to the LEAGUE affected, of at least eight (8) days.

RESPONSIBILITIES OF THE LEAGUE:

1. The LEAGUE agrees to furnish the COURSE a roster of its members and their addresses and this shall be made of the official contract, no later than _____.
2. The LEAGUE will notify the COURSE 30 minutes in advanced of tee-off time if they consider the weather disallows play. The LEAGUE agrees that any postponement cannot be rescheduled.

3. The LEAGUE shall be responsible for all damages to the COURSE and/or facilities provided by said COURSE due to negligent and/or deliberate conduct on the part of said LEAGUE members.
4. If the LEAGUE leaves the first tee after deciding the weather is unfavorable, no rain checks will be issued.
5. The LEAGUE will be responsible for posting the entire season schedule, weekly scores and standings.
6. The LEAGUE agrees to play nine holes of golf with in two hours and fifteen minutes or less from starting tee time.
7. ALL LEAGUES must follow course rules.

IT IS AGREED THAT THE LEAGUE WILL START IMMEDIATELY UPON THE TEES BECOMING AVAILABLE AND COMPLETE LEAGUE PLAY WITHIN THE PRESCRIBED CONTRACT TIME. NO EXTRA GOLF IS COVERED BY THIS AGREEMENT.

It is further agrees that no oral or written agreements have been entered into between the parties covering this contract, giving any additional consideration, extra service, bonus, or inducement, and this Agreement is the entire Agreement between the parties.

ALL LEAGUES shall retain their right of preference in signing their league, for the following year, until November 1, 2025.

Any LEAGUE without a signed contract for the 2025 year by December 1, 2025 will be accepted on a basis of when the application is received and available facilities.
